# STATUTORY RESOLUTION NO. 42-2016

# AMENDING RESOLUTION 13-90 AND AS AMENDED BY OTHER RELATED RESOLUTIONS TO EXTEND THE EXEMPTION OF IMPROVEMENTS FOR AN ADDITIONAL FIFTEEN YEARS

WHEREAS, the Board of Township Trustees (the "Board") of West Chester Township, Butler County, Ohio (the "Township") has previously adopted Resolution No. 13-90, on April 23, 1990, as amended by Resolution Nos. 91-17, 16-2002, 41-2004, 45-2006, and 34-2016, adopted on July 9, 1991, May 5, 2002, July 13, 2004, December 5, 2006 and December 6, 2016, respectively, which declared certain improvements in the Township to be a public purpose and exempted certain property from taxation; and,

**WHEREAS**, for participating properties, the Township and or respective property owners filed the required Department of Taxation and Equalization exemption applications for the properties set forth on Exhibit A, attached hereto, which have been approved for exemption by the Tax Commission of the State of Ohio; and,

**WHEREAS**, according to the 2010 Census, West Chester Township, Butler County, Ohio has a population of 60,958; and,

WHEREAS, this Board has determined it will be in the best interest of the Township and its citizens to extend the exemption from real property tax of certain improvements in the Township and to declare certain improvements to parcels of real property located in West Chester Township (fka Union Township) to continue to be a public purpose and exempt such improvements from real property taxation as illustrated on Exhibit B as attached hereto; and,

WHEREAS, this Board further determined the extension of such exemption and the extension of such declaration will be consistent with the economic development plans of the Township in furtherance of the goals set forth in the Township's economic development and strategic plan; and,

WHEREAS, notice has been provided to the Boards of Education of the Lakota Local School District, the Princeton City School District, and the Butler Technology and Career Development Schools, and the Board of Commissioners of Butler County, Ohio of this Board's intent to extend the exemption from real property tax of improvements to those parcels set forth on Exhibit A attached hereto and to extend the declaration of certain improvements to parcels of real property to continue to be a public purpose and exempt such improvements from real property taxation as illustrated on Exhibit B as attached hereto.

**NOW THEREFORE BE IT RESOLVED** the West Chester Township Board of Trustees does hereby agree to:

**SECTION 1.** Authorize and approve the extension of the real property tax exemption granted and the extension of certain improvements to parcels of real property to be a public purpose and exempt such improvements from real property taxation declared by

Resolution No. 13-90, as amended by Resolution Nos. 91-17, 16-2002, 41-2004 and 45-2006, pursuant to Ohio Revised Code Section 5709.73, for the property set forth on Exhibit A, attached hereto, and Exhibit B, attached hereto, for an additional period of fifteen years, as provided by Ohio Revised Code Section 5709.73 (L).

**SECTION 2.** Direct the Township Administrator to file a copy of this Resolution with the Boards of Education of the Lakota Local School District, the Princeton City School District, and the Butler Technology and Career Development Schools, and the Board of Commissioners of Butler County, Ohio, Butler County Auditor, the Tax Commissioner of the State of Ohio and the Ohio Department of Development.

**SECTION 3**. Authorize the Township Administrator, upon approval of bond counsel, to provide, complete, execute, and deliver any and all forms or documents required by the County Auditor or the Tax Commissioner to effectuate the intent of this Resolution and the extension of the exemption.

**SECTION 4**. Find and determine that all formal actions of the Board concerning and relating to the adoption of this resolution were adopted in an open meeting of the Board; and that all deliberations of the Board and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 5.** Determine this Resolution shall take effect at the earliest date permitted by law.
